The reason there has been a "slaughter" of the appendix, is because since the formation of the Surgeons organizations, propaganda has been spread throughout the world to "promote" operations for removal of the appendix. Doctors preach that the appendix was formerly a second stomach and since the beginning of man has dwindled away until now it is only a little tube or sack and of no use to the body. ~ The appendix is the most important organ in the body for its size and weight. It is said that the secretion from the appendix is so strong it will dissolve the white of an egg in 14 minutes. Notice the appendix appears as a chord, running the full length of the ascending, transverse and descending colon. See picture.

A mechanic would say, the appendix is the elevator boy, the starter. When foodstuff gets into the colon, the secretion from the appendix enters and mixes with same, it lubricates the foodstuff going upwards in the ascending colon; it is a powerful antiseptic and agitator for controlling the lobe muscles which move the load upwards like an elevator. Death from appendicitis operation has increased from 8 to 16 per 100,000 since 1910, which spells failure to allopathic methods.

CANCER Why Operations . . . X-ray Radium Fails

CANCER is a systemic condition, it shows in the blood stream and a cancer cell cannot be seen without a microscope. It cannot be seen with a microscope unless the cancer tissue is frozen, cut to a thinness of about one-thousandth of an inch and stained with a dye. Even then a doctor or pathologist cannot be certain. Doctor Joseph Colt Bloodgood of Johns Hopkins Hospital, Baltimore, who was classed as one of the world's best cancer experts, testified in the Federal Court, Davenport, Iowa, in the case of Baker vs. American Medical Association that he did not know what cancer was or what caused it. The medical record quotes Dr. Bloodgood saying he has submitted histologic specimens in over 60 doubtful cases to a number of eminent pathologists and in not a single one of them was there a uniform agreement as to whether the lesion was benign or malignant. It is as foolish to try to cure cancer by only a local treatment to remove or dry up a syphilitic sore knowing it is a blood condition. his condition when he came to us. The odor was so bad, it could be detected a great distance. At home he was forced to sleep on pillows covered with rubber because of the large amount of pus secreted each night. His wife daily washed his head by having him lean over a 5-gallon pail while she poured the fluid over his head. It was a terrible case; our doctors moved to enable us to treat the condition better.
